## **Wildfire Protection for All Residents of Morgan Hill**

*Defensible Space clearing for the Wildlife Education and Rehabilitation Center*

Nestled among the foothills of the Diablo Mountains in Morgan Hill sits the quiet, secluded sanctuary for wildlife known as W.E.R.C. – the Wildlife Education and Rehabilitation Center. Home to injured, sick and orphaned animals such as birds of prey, bobcats, reptiles, and jackrabbits, W.E.R.C. operates as a temporary rehabilitation refuge and releases animals back into their native habitat healthy, wild, and free. Licensed by California Department of Fish and Game and by the U.S. Fish and Wildlife Service to care for native wildlife, it is the only such facility in Santa Clara County.

The CAL FIRE Santa Clara County unit knew that the W.E.R.C. property was in great need of clearing and maintenance as many animal cages had overhanging trees and branches. Structures needed appropriate Defensible Space and posed a serious fire threat.

“This was a one of a kind project for us because we not only helped the W.E.R.C. facility and the surrounding properties, but are also protecting the wildlife that resides here,” states Kellie Guerra, South Santa Clara County FireSafe Council Area Manager.

During several site visits, the FireSafe Council worked with CAL FIRE on clearing and safety recommendations and with W.E.R.C. to ensure the safety of the animals. As a non-profit organization, W.E.R.C. qualified for the Special Needs Assistance Program, which provides free Defensible Space clearing and chipping. The result was the clearing and chipping of five large piles of hazardous fuel and the removal of nine dead, dying, or otherwise dangerous trees.

## **FireSafe Director Spotlight: Getting to Know the Team** *Chris Hughes, Pacific Gas and Electric Company*

This month the spotlight is on Chris Hughes. Chris is a Forester with PG&E and a member of our Board of Directors.

*How long have you been involved with the FireSafe Council? Why did you become involved?*

I have been involved with Fire Safe Councils since 1997 and a member of the Santa Clara County FireSafe Council since 2001. With my responsibilities with PG&E, my participation is a great fit as both organizations are working towards similar goals: with proper education, residents can have a beautiful, fire wise garden that is also compatible with the high voltage lines.

*What is your main role or area of expertise within SCFSC?*

I'm current on the Board of Directors where my experiences with contracts and running projects with PG&E has come in handy with providing advice to the council.

*What are some of the biggest challenges and opportunities for the FireSafe Council?*

The biggest challenge that we face as a FireSafe Council is that property owners believe that the fire will only happen in their neighbors yard. One thing I have learned working with fire professionals is that its not a matter of if a fire starts, but simply a matter of when.

*What is your favorite thing about Santa Clara County?*

I enjoy the densely covered hills in Santa Clara county especially taking shade under them on a warm day. Such wonderful natural sites seems at odd to an area known for its technology.

*Describe a memorable project or event. Why did it make such an impression on you?*

Several years ago, while braining storming fundraising ideas, we ended up with PG&E donating a tree suitable under power lines, and a landscape contractor who was attending the FireSafe Council meetings donated the planting of the tree. The combination went up for a silent auction and brought in a good deal of money. It really showed me how, working together, we are greater then our parts.
